

Terms of Service & Waiver of Liability

I, guest of Aroma's Tobacco Inc. (hereinafter referred to as "Aroma's"), acknowledge that I must follow a certain code of conduct while inside this establishment as provided in this Terms of Service & Waiver of Liability ("Agreement"). I further acknowledge that Aroma's reserves the right to refuse service at any time and for any reason.

Without a signed copy of this Agreement, I may be asked to leave the lounge. For purposes of my signature a typed name and email address will represent my signature and acceptance of the Agreement.

At the door: I acknowledge that I will follow all laws within the state of Illinois, especially those related to controlled substances. If I am participating in Aroma's bring-your-own marijuana services, I affirm that all cannabis entering the lounge has been acquired legally and falls within the state's possession limits. I affirm that I am at least 21 years of age and will provide proof of such upon request by Aroma's staff.

Aroma's strictly prohibits edible cannabis and smoking devices used to attain egregious levels of inebriation, such as gas masks. I agree not to use such devices. I also hereby agree to follow all policies posted within the lounge. Aroma's has the right to retain a copy of this Agreement for any future visits, and I agree to comply with all of its terms and conditions on any subsequent visit to Aroma's.

During my stay: I acknowledge that the air may be filled with THC, which can potentially cause inebriation and could result in testing positive for marijuana in a drug screening. I further agree that Aroma's is not fiscally, legally, or medically responsible for any side effects from smoke inhalation or inebriation, such as bodily injury or fainting.

Waiver of Liability. I hereby waive my legal rights to any occurrence involving my use or misuse of cannabis. In the unlikely event that I require medical attention I give Aroma's and its staff permission to call for emergency medical services at my expense. I acknowledge that Aroma's has the right to remove me from the establishment if I become too inebriated or become a danger to myself or others. I further waive any and all liability against Aroma's to the extent allowable under applicable law.

I understand and agree that Aroma's employees are not allowed to handle any cannabis products unless destroying them. Aroma's does not sell cannabis. I agree that I will not purchase or sell cannabis products within the establishment.

Before leaving: I agree to seal and secure any cannabis before exiting the establishment in such a way that I cannot easily access them while operating a motor vehicle and in compliance with Illinois cannabis law. Because Aroma's is unable to handle any cannabis products, any such product that I leave in the establishment will be immediately destroyed. I assume all liability for my use of cannabis while at Aroma's and will be responsible in my consumption of cannabis on premises.

After leaving: I acknowledge that Aroma's is not fiscally, legally, or medically responsible for any occurrences related to cannabis consumption outside of the establishment, such as motor vehicle accidents or inability to pass a drug test. I hereby waive my legal right to any such occurrence involving my use of cannabis within the establishment. I assume all liability for my use of cannabis while at Aroma's.

I acknowledge that I have read the terms and conditions of this Agreement and accept it in its entirety. No oral agreements have been made regarding this Agreement. This Agreement expresses the terms and conditions of usage of cannabis at Aroma's in its entirety and amendments to this agreement shall be void unless in writing and signed by both Parties. A copy of this Agreement will be given to me upon its execution.
